Submissions should be made via the CES website at www.china-ces.org by no later than **February 29, 2016**. Decisions on the submissions will be provided by **March 15th, 2016**.

An organized session usually includes 3-4 paper presentations, discussants, and a session chair. GREGORY CHOW BEST PAPER AWARD

We will select a paper presented at this conference by a junior scholar for the Gregory Chow Best Paper Award. To be considered, the primary author of the paper must be a graduate student or a junior scholar who received his/her PhD within the last five years. The award winner will receive a US \$1,000 prize.
